We reserve the right to ensure the safety and well being of all campers and to dismiss a camper, without refund, for misconduct for unsociable behavior as determined by the Directors.

CREATIVE SPACE HAWAII LIABILITY WAIVER 2012

Summer camp is a wonderful experience for boys and girls and teaches them a great deal about themselves and the world around them. Part of the magic of camp is that the activities take place in the out of doors and campers are invited to explore new challenges. Obviously, with these challenges comes risk. Our purpose in this disclosure is not to worry you, but to point out that there are risks connected with the fun, excitements and adventure of a camp experience.

Assumption of Risk. You, as parent and/or guardian of your Child(ren) are aware of the inherent risks of injury, death, and property damage involved in camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, snorkeling, kayaking, etc. including without limitation risks due to drowning, near drowning, falls, etc. You as parent and/or guardian of your Child(ren) are aware of the risks of injury, death and property damage that may result from, among other causes, the act of active and passive negligence of Creative Space LLC and all officers, directors, employees, agents, representatives, successors, and assigns (collectively, "related parties"), including without limitation the risk of negligent instruction or supervision. You as parent and/or guardian have voluntarily allowed your Child(ren) to engage in activities including but not limited to ropes course, surfing, climbing, swimming, diving, snorkeling, kayaking, etc., with knowledge of the risks of injury, death, property damage, and other risks, and assume any and all known and unknown risks of injury, death, and property damage that may result from camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, snorkeling, kayaking, etc.

Release of Liability. You as parent and/or guardian of the Child(ren) hereby release the related parties from all liability to you as parent or guardian, and or Child(ren), principals, employees, agents, representatives, guardians, successors, assigns, heirs, and next of kin for all liability, claims, damage, or demands from personal injury, death, or property damage, arising from or related to this agreement or to camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, snorkeling, whitewater rafting, kayaking, etc., whether the injury, death or property damage occurs on or off the premises. This release includes, without limitation, any personal injury, or property damage caused by the active or passive negligence of any of the released parties. You as the parent and/or guardian of the Child(ren) bear sole responsibility for any loss.

Hold Harmless. You as parent and/or guardian shall indemnify, defend, and hold harmless Creative Space LLC, all officers, directors shareholders, employees, agents, representatives, successors, and assigns (collectively "indemnities"), against all liability, demands, claims, costs, losses, damages, recoveries, settlements, and expenses (including interest, penalties, attorney's fees, expert witness fees, costs, and expenses incurred by indemnities ("losses"), known or unknown, contingent or otherwise, directly or indirectly arising from or related to your Child(ren)'s participation in Creative Space Camp LLC activities.

Choice of Law; Jurisdiction. All questions with respect to the construction of this agreement and the rights and liabilities of the parties shall be determined in accordance with the applicable provisions of the laws of the state of California.

Knowing and Voluntary Execution. You as parent and/or guardian of the Child (ren) acknowledges that you have carefully read this agreement, understand its contents, understand that this agreement includes an assumption of the risk of the released parties negligence and a release of their liability, You as parent and/or guardian of the Child(ren) acknowledge that Creative Space is materially relying on this waiver and is allowing your Child(ren) to engage in camp activities including but not limited to ropes course, surfing, climbing, swimming, diving, snorkeling, kayaking, etc.

No refund or adjustment is made if, with or without prior notice, Creative Space changes its program by adding, altering, or deleting activities.

Creative Space cannot accept responsibility for any personal item lost or damaged by fire, theft, or in the laundry.

Creative Space may use any pictures or videos taken of campers and families during camp time. This includes digital images, which may be posted on our web site. **We may transfer the rights to use images of campers to third parties.**

It is essential that any pertinent information, including any social, emotional or physical problems that might limit a camper's active participation in camp activities be discussed with the directors prior to acceptance and attendance at camp. We want this to be a successful experience for the camper and the camp. This confidential information may be sent by letter, telephone, or fax.

I allow Creative Space to share my camper's contact information with others in his/her cabin or group (Creative Space will not release my camper's information to anyone else).
